Public Statement on Earl Abdul-Malik and The 2023 Community Development and Leadership Conference

(9/29/2023)

PLEASE BE INFORMED THAT EARL ABDUL-MALIK IS NOT INVITED AND WILL NOT BE PARTICIPATING IN THE 2023 Community Development and Leadership Conference in Orlando, Florida. THIS CONFERENCE IS A SERIOUS EFFORT FOR SERIOUS COMMUNITY LEADERS, DOING REAL WORK, ON BEHALF OF THE COMMUNITY OF IMAM W. DEEN MOHAMMED. NONE OF THESE CHARACTERISTICS APPLY TO EARL ABDUL-MALIK. In addition, Earl Abdul-Malik recently proclaimed to the world that *he had separated himself from our Community and its leadership*. He also urged his small band of followers to *find new people (outside of our Community) to follow him*.

In our 2019 statement (*see link below*) on Earl Abdul-Malik, we documented the evidence of his two-decade pattern of criminal behavior of theft, fraud, and immoral conduct. While in prison for such conduct, of which he pled **GUILTY**, he started another scam. He claimed he was the representative of Imam W. Deen Mohammed! After we produced **clear evidence that Imam Mohammed DISMISSED HIM FROM OUR COMMUNITY and NEVER REINSTATED HIM**. He changed his scheme and claimed to be Imam W. Deen Mohamed's successor!

Since his recent release from federal prison, Earl Abdul-Malik has tried to gain traction with his latest fraud, wrapping himself in his past associations with Imam W. Deen Mohammed. He conveniently overlooks the period after he was dismissed (*by Imam Mohammed*), indicted twice, and convicted for lying, cheating, and stealing over \$4 million (*in a fraudulent gold scam*). In his delusions, he proclaims that he is the only one that can represent and communicate the legacy of our Imam. He also fails to take responsibility for his un-Islamic behavior, criminal actions, or misappropriations from members of our Community.

As a result, Earl Abdul-Malik and his people have been overwhelmingly rejected and condemned by believers and leaders in our Islamic community. His most recent embarrassment came when he announced a big public address about our conference scheduled for Mobile, Alabama. When he was turned away by the Imam and the Masjid, he faced another public humiliation. In a flailing attempt to save face with his small band of followers, he now announces that he and they are coming to our conference in Orlando, Florida.

LET US BE ABSOLUTELY CLEAR! UNTIL HE: 1) REPENTS, 2) PUBLICLY ADMITS HIS CRIMES, 3) SEEKS OUR COMMUNITY'S FORGIVENESS, 4) PAYS BACK THE MANDATED \$4.4 million in RESTITUTION TO THE VICTIMS OF HIS CRIMES, and 5) REPAYS THE MANY BELIEVERS HE HAS SCAMED IN OUR COMMUNITY; HE AND HIS ASSOCIATES ARE NOT WELCOME IN OUR COMPANY!!

IN ACCORDANCE WITH THE CRITERIA OF OUR RELIGION, HE CERTAINLY CANNOT BE CONSIDERED A LEGITIMATE ISLAMIC LEADER, AND WE WILL NOT PRETEND THAT HE IS!
